

## TORONTO GOLF AND TRAVEL SHOW CONTEST

### OFFICIAL CONTEST RULES

**1. Agreement:** These rules govern the Toronto Golf and Travel Show Contest (“Contest”). No purchase is necessary to enter the Contest. The act of entering the Contest constitutes acceptance of the Contest rules and the decisions of the Sponsor, which decisions shall be final and binding upon all entrants.

**2. Sponsor & Prize Providers:** The Toronto Star Golf and Travel Show, a division of Metroland Media Group Ltd. (the “Sponsor”). The prize providers are Jamaica Tourism, Swoop Inc., Hilton Hotels, and the Cinnamon Golf Club (the “Prize Providers”).

**3. Eligibility:** The Contest is open to residents of Ontario, who have attained the age of 21 at the start of the Contest Period. Notwithstanding the above, the Contest is not open to employees, immediate family members (i.e. spouses or biological, step or adoptive parents, children or siblings) or anyone domiciled with any employee of the Sponsor or Prize Providers or any of their respective affiliates, subsidiaries, advertising or promotional agencies or fulfillment houses. Incomplete or illegible entries, bulk drop offs, photocopies, scanned copies, facsimiles or other mechanically or electronically reproduced entries will not be accepted and will be disqualified. Limit of one (1) entry per person during the Contest Period.

**4. Contest:** The Contest Period begins on January 12, 2023 at 9:00 a.m. ET and ends on February 5, 2023 at 5:00 p.m. ET. There are two ways to enter the Contest and be eligible to win a prize:

(a) **Online:** during the Contest Period, access the Contest website at <https://www.torontogolfshow.com/contests/visit-jamaica-with-swoop-airlines-contest/>, read these Contest rules, and follow the instructions to enter, complete and submit a Contest entry form (a valid email address will be required). Each entrant may use only one email address to enter the contest.

OR

(b) **At the Golf and Travel Show:** Attend the Toronto Golf and Travel Show held at the International Centre located at 6900 Airport Rd. Hall 5, Mississauga ON L4V 1E8 from February 3<sup>rd</sup> to 5<sup>th</sup> 2023 during show hours, scan the QR code posted at the show location, follow the instructions to enter, complete and submit a Contest entry form (a valid email address will be required). Each entrant may use only one email address to enter the contest.

**5. Winner Selection:** The potential winner will be chosen by random draw from all eligible entries received, which will take place at the Sponsor’s office at 8 Spadina Avenue, 10<sup>th</sup> Floor, Toronto, Ontario M5V 2H6 on February 6<sup>th</sup>, 2023. The potential winner will be contacted by telephone or email by a representative of the Sponsor and must reply within 2 business days to maintain eligibility. If the potential winner cannot be contacted within this time period or fails to respond to any attempted contact or incorrectly answers the skill testing question, such potential winner will be disqualified, his/her entry will be declared null and void and the Sponsor reserves the right, in its sole and absolute discretion, to select at random another eligible entry, in which event these provisions shall apply to such

other eligible entry. In order to be eligible to win, the potential winner must correctly answer a mathematical skill-testing question without assistance or mechanical or electronic aid.

**6. Prize:** There is one (1) prize available to be won consisting of the following:

- i. Two (2) Swoop Airline return economy airfare tickets, (one (1) for the winner and one (1) for their travelling companion) to Sangster International Airport in Jamaica, departing from Toronto, Ontario;
- ii. Four (4) night stay for two (double occupancy) at Hilton Rose Hall Resort and Spa located at Rose Hall, Main Road, Montego Bay, Jamaica;
- iii. One (1) round of golf for two at the Cinnamon Golf Club located at Hilton Rose Hall Resort and Spa.

Approximate retail value of the prize is \$4,500.00 CAD. Actual value of the prize will be dependent upon airline fare fluctuations; any difference between stated approximate value and final value of a prize will not be awarded.

Trip must be completed by December 18, 2023 or the prize will be forfeited in its entirety. Specific travel dates and arrangements are subject to air travel, hotel and holiday blackout dates, and other prize and travel restrictions. Blackout dates include but are not limited to February 5, 2023 to April 30, 2023 and all holidays and holiday weekends that include a Friday and Saturday. Travel dates are subject to Prize Providers and Sponsor approval. Reservations are subject to availability. Trip must be booked within ten(10) weeks of the winner accepting the prize. All elements of the prize must be redeemed at the same time, and no changes will be permitted after confirmation or any redemption.

Unless a child or ward of the winner, the guest must be eighteen (18) years of age or older as of the date of departure. The guest must travel on the same itinerary and at the same time as the winner. A minimum of one person, either the prize Winner or his/her guest must hold a valid credit card to cover any incidentals or any other requirement that may be required at the hotel upon check-in.

The prize consists only of the elements expressly set forth above; no other elements or expenses (including, without limitation, insurance, meals, beverages, air, train and ground transportation from the winner and guest's residence to Toronto Pearson Airport and at destination, phone calls, baggage, gratuities, incidentals, souvenirs, gasoline, etc.) are included in the prize and all such expenses are the sole responsibility of the winner and his/her guest. The winner and guest are responsible for any air travel taxes and/or expenses, including applicable departure taxes or fees, inspection charges, baggage fees, and security charges. Winner and guest are responsible for obtaining, at their own expense, any necessary travel documentation (i.e. valid photo identification, visas, passports, etc.) prior to travel. The winner and his/her guest must possess a valid Canadian Passport and it must be valid for at least 6 months beyond the intended stay. Once issued, tickets are non-transferable and may not be reissued once travel has commenced. Open tickets may not be issued, and stopovers are not permitted. Travel arrangements must be made through Prize Providers.

If the winner elects to partake in any or all portions of his/her prize without a guest, the prize will be awarded to the winner, and any remainder of the prize not awarded will be forfeited and shall not be subject to further or alternative compensation. Requests for substitutions and itinerary changes will not be considered. There is no refund or credit for unused portions of the prize. The prize is non-refundable, non-transferable, not for sale and has no cash surrender or redemption value. Sponsor and the Prize Providers reserve the right in their sole discretion to substitute another prize of equal or greater value for any component of the prize, without liability.

**7. Release:** Prior to receiving the prize, the winner and his/her guest(s) will be required to show valid photo ID and to sign a declaration of eligibility and release form releasing the Sponsor, Prize Providers and each of their related parties from any and all liability in connection with the Contest and/or the prize, confirming compliance with the Contest rules and consenting to the use of his or her name, image, likeness, video, comments, and photographs, in any and all forms of media, without further compensation, in any publicity carried out by the Sponsor, the Prize Providers, and/or each of their respective advertising and promotional agencies. The signed form must be received by Sponsor within 2 business days of notification or the prize may be forfeited and awarded to an alternate entrant. The winner and his/her guest(s) may be required to sign additional releases upon request by the Sponsor or the Prize Providers.

**8. Indemnity:** By participating in this Contest, you agree to defend, indemnify and hold harmless the Sponsor and Prize Providers and any other prize supplier and each of their respective parents, subsidiaries, affiliates and/or related companies and licensees and each of their officers, directors, shareholders, employees, advisors, assignees, agents, licensees, representatives, advertising, media buyers and promotional agencies (the "Released Parties") from any and all damages, injuries, claims, suits, actions, causes of action, costs, expenses, liabilities or losses of any kind (including but not limited to lawyers' fees) arising out of or relating to your participation in the Contest; your receipt or use of any prize; or your violation of any term of these Contest rules or your violation of any third party right, including without limitation any copyright, property, or privacy right.

**9. Privacy:** The Sponsor uses your personal information to administer this Contest, including contacting, announcing and promoting the winner, and may transfer your personal information to third party service providers (including but not limited to the Prize Providers) in order to perform services such as prize fulfillment and delivery. The Contest is run in compliance with the Sponsor's privacy policy, which may be found in full at <http://notices.torstar.com/privacy-policy/index.html>.

**10. Banning:** The Sponsor may, in its sole discretion, prohibit any person from entering the Contest whom it believes to be abusing the rules. Such abuse includes entering false information and entering more times than permitted.

**11. Social Media Disclaimer and Release:** This Contest is in no way sponsored, endorsed or administered by, or associated with, Facebook, Inc. or Twitter, Inc. (together, the "Social Media Platforms") You understand that you are providing your information to Sponsor and not to the Social Media Platforms. Any questions, comments or complaints must be directed to the Administrator, and

not to the Social Media Platforms. By participating in the Contest, each entrant releases and agrees to indemnify the Social Media Platforms and hold them harmless from and against any and all costs, claims, damages, (including, without limitation, any special, incidental or consequential damages), or any other injury, whether due to negligence or otherwise, to person(s) or property (including, without limitation, death or violation of any personal rights, such as violation of right of publicity/privacy, libel, or slander), due in whole or in part, directly or indirectly, to participation in the Contest, or arising out of participation in any Contest-related or prize-related activity, or the receipt, enjoyment, participation in, use or misuse, of any Contest or prize-related activity, whether hosted by Sponsor or a third party.

**12. Other:** Odds of winning depend on the number of eligible entries received. This Contest is governed by the laws of Ontario and the laws of Canada applicable therein and is void where prohibited by law. The Sponsor reserves the right to cancel or modify the Contest or the Contest rules at any time without notice. All prizes must be accepted as awarded, are non-transferable and are not convertible to cash. The Sponsor or Prize Providers reserve the right to substitute any prize or portion of a prize with a prize of equal or greater value. All prizes are awarded as-is and no warranties or guarantees are implied or expressed. Neither the Sponsor nor any Prize Provider is liable for any lost, late, misdirected or stolen entries or inability to process entries, or any errors, damage, injury or negligence that may arise in connection with this Contest, including technical issues or failures on any website or software, viruses, website disruptions, malfunctions or website down-time, human error, personal injury or property damage incurred by any Contest entrant. Sponsor is not responsible for any errors or omissions in printing or advertising this Contest. Use of any automated system including robotic or form filling software to enter or participate in this Contest is prohibited and will result in disqualification of all entries by anyone using such assistance. If a dispute arises regarding who submitted an online entry, the entry will be deemed to be submitted by the authorized account holder of the email address provided at time of entry. The authorized account holder is the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted email address.
